## Lawton City Council September 11, 2024

The Lawton City Council met in regular session at 5:30pm on September 11, 2024, in the council chambers at 315 Ash St. Mayor Pedersen called the meeting to order around 5:30pm. Roll call was answered by Nelson, Otto, Roth, and Saunders.

Agenda: motion by Otto, second by Saunders to move General Business item #1 and #2 to the beginning of the meeting and approve the rest of the agenda as posted.

Public hearing: Mayor Pedersen opened the public hearing for the proposed sale of real property at 5:34pm. Attorney Beardshear presented Resolution 2024-13 Sale of Real Property which contains the terms of the sale. Nathan Niehus reviewed the conditions of the resolution. With no other comments received, Mayor Pedersen closed the public hearing at 5:41pm.

## Resolution 2024-13 Sale of Real Property

Motion by Saunders, second by Nelson to approve the sale of the property "Beginning at the Southwest corner of Lot Eight (8) in Sparr's Hilltop Acres, First Addition, to the Town of Lawton, Iowa, thence Southeasterly along the South boundary of said Lot Eight (8) a distance of twenty-two (22) feet, thence South parallel with the West line of the East one-half (E ½) of the Southeast Quarter (SE ¾) of Section Thirty-two (32), Township Eighty-nine (89) North, Range Forty-five (45) West of the 5th. P. M., a distance of Seventeen (17) feet, thence Northwesterly parallel with the said, South line of said Lot Eight (8) a distance of Twenty-two (22) feet to the West line of the said East one-half (E ½) of said Southeast Quarter (SE ¾), thence North along said West line of the East one-half (E ½) of the Southeast Quarter (SE ¾) of Section Thirty-two (32), Township Eighty-nine (89) North, Range Forty-five (45) a distance of Seventeen (17) feet to the point of the beginning", all contained within the City of Lawton, Woodbury County, IA, also known as parcel #894532427013 to Nathan Niehus and Rebeka Niehus for the price of \$1,000. Motion carried on a roll call vote with all present members voting aye.

Public forum: no comments were made during public forum.

Public works report: Director reported the shelter at the new park will be built within the next few weeks with a donation from WiaTel and he will be attending a conference for continuing education.

Attorney report: Beardshear reported working on a couple nuisance properties in town.

Motion by Roth, second by Otto to approve the September disbursements and August claims for payment and financial reports. Motion carried with all voting aye. Motion by Saunders, second by Nelson to approve the utility billing trial balance and accounts receivable audit report. Motion carried with all voting aye.

Special event permit: motion by Otto, second by Saunders to approve the special event permit from the Lawton-Bronson CSD for a Homecoming Parade on September 20, 2024. Motion carried with all voting aye.

American Rescue Plan: discussion on potential projects for unused funds required to be used by December 31, 2024.

With no further business, motion by Saunders, second by Nelson to adjourn the meeting at 6:05pm. Motion carried with all voting aye.
